

A. NON-CONFIDENTIAL FACTS AND ADVICE TO THE PCC

A1. INTRODUCTION AND BACKGROUND

1. The Police and Crime Commissioner recognises the role that the voluntary and community sector, communities and individuals can have in preventing crime and making the places where they live and work safe.
2. The Commissioner has made resources available through a Community and Volunteer Fund (<http://www.lincolnshire-pcc.gov.uk/News-and-Events/News-Archive/2013/Community-and-Volunteer-Fund.aspx>) to assist small local, community based groups in reducing crime and anti-social behaviour and supporting the victims of crime. In particular, the Commissioner would like the Fund to support as many smaller projects as possible, projects which are aimed at younger and older members of the community and which are supporting victims, witnesses and vulnerable people.
3. A Fund of £30,000 has been set aside for 2013-2014 with grants awarded for projects and initiatives that contribute to the Commissioner's priorities as set out in his Police and Crime Plan 2013-2017 (<http://www.lincolnshire->

#### **APPLICATIONS**

4. Following the award of grants published in Decision Report 022/2013 dated 18 July 2013, a further two applications have successfully met the funding criteria. These are detailed at Appendix A.
5. Each organisation that is awarded a grant must submit an evaluation and monitoring report by 31 March 2014 to confirm that the grant has been used for the purpose originally requested and to evaluate its effectiveness in contributing towards the achievement of the priorities in the Police and Crime Plan.

#### **A2. LINKS TO POLICE AND CRIME PLAN AND PCC'S STRATEGIES/PRIORITIES**

Grants are awarded for projects and initiatives that contribute to the Commissioner's priorities as set out in the Police and Crime Plan 2013-2017.

#### **B. FINANCIAL CONSIDERATIONS**

The available fund is £30,000 of which £6,050 has thus far been allocated to applicants leaving a balance of £23,950.

#### **C. LEGAL AND HUMAN RIGHTS CONSIDERATIONS**


