A. NON-CONFIDENTIAL FACTS AND ADVICE TO THE PCC

A1. INTRODUCTION AND BACKGROUND

- The Police and Crime Commissioner has made clear his plan for crime and policing in Lincolnshire through the Police and Crime Plan. Amongst other things this outlines an aspiration to reach 1000 volunteers by 2017 and to create an efficient and effective force.
- Two areas where the force is currently restricted by its current outdated and overly manual systems are in Vetting and Data Protection.
- This paper requests a decision regarding the purchase of an electronic vetting and Data Protection IT system that will address these restrictions and deliver savings in the future.
- 4. With regard to vetting, under the current system we are required to retain a huge number of files in hard copy and the further requirement to complete vetting on volunteers under the Commissioner's Police and Crime plan will increase this further. The proposed Cyclops system will resolve this by providing and electronic storage solution.

- The Cyclops system is also the regional choice, with investment from all five regional forces committed to improving performance and efficiency moving forward.
- 6. Under the Data Protection Act there is a requirement by law to redact all information appropriately to ensure all third party data is removed prior to disclosure. Currently this can only be completed by printing off all the information in hard copy form (single sided) and redacting the information manually, word by word using a black marker pen. Then because the marker pen does not adequately hide the information, copying all the redacted information, sometimes twice, to ensure it can not be seen by the applicant. This is not only a hugely labour intensive task but also extremely inefficient with regard to both cost to the organisation and the accuracy of copies and potential for information to be lost or amalgamated with other orders.
- 7. Consequently, the purchase of the Cyclops system will not only result in savings year on year on our current processes but also improve efficiency to the extent that additional workload in both business areas can be absorbed more easily. The force is therefore seeking to purchase the Cyclops system.

A2. LINKS TO POLICE AND CRIME PLAN AND PCC'S STRATEGIES/PRIORITIES

The purchase of the Cyclops system will improve efficiencies in both the data Protection and Vetting business areas. This will in particular assist in the aspirations outlined in the Police and Crime Plan to achieve 1000 volunteers by 2017 and to achieve value for money and cut waste in the organisation.

B. FINANCIAL CONSIDERATIONS

The introduction of this system will result in substantial savings on our current processes that will see the system paid for within two years and thereafter a net saving year on year.
