The Commissioner is invited to consider suspending from duty Mr Rhodes while investigations are pending. It is emphasised that suspension is a neutral act and it should not be inferred that the potential conduct matters have been proven if a decision to suspend Mr Rhodes is taken.
- 1.2 Should the decision be made to suspend Mr Rhodes, the Commissioner is invited to consider whether a referral should be made to the Independent Police Complaints Commission.
