## A. NON-CONFIDENTIAL FACTS AND ADVICE TO THE PCC

## A1. INTRODUCTION AND BACKGROUND

- Following consideration and approvals by the Transactional Management Board on the 18/12/15, Chief Officer Group 16/02/16 and the Steering Group (OPCC) 19/04/16, approval is sought to proceed with the procurement of the Force wide installation of LED lighting utilising in part the Government backed SALIX Finance funding model.
- 2. In brief this project will allow for the replacement of old lighting systems with energy efficient LED lighting systems at twenty four Police Stations around the Force leading to a significant annual revenue saving. To allow the procurement of this project to progress, formal approval of an amendment to the Capital Programme is now required. It is proposed to fund the scheme utilising long term borrowing in conjunction with short term financial support from SALIX Finance.
- 3. The Salix Finance scheme is a national government backed scheme which provides interest free support to energy efficiency projects. It is proposed that if available this

funding is used to support the cash flow required for the scheme in the early years. In order to finance the project long term it is proposed that the scheme is financed by PWLB loan over a 20 year loan period, which is the anticipated life of the equipment.

- 4. The loan from SALIX Finance is to be paid back be paid in eight instalments over a period of four financial years commencing in either April or October after practical completion of the project whichever is soonest.
- 5. It should be noted that in the event that SALIX funding is not available the scheme will still progress in order to achieve the revenue savings. The Business Case identified an annual saving of £93.4k which after allowing for financing costs of £29.7k per annum would result in a forecast long term saving of £63.7k per annum.

# A2. LINKS TO POLICE AND CRIME PLAN AND PCC'S STRATEGIES/PRIORITIES

The LED lighting replacement project supports the Police and Crime Plan Key Objectives as can be seen in the summary in the extract from Section 4 of the Estate Strategy 2016-2019

## B. FINANCIAL CONSIDERATIONS

Extract from Section 8 of the Force wide installation of LED lighting Business Case dated 15/13/15:

### **Chief Finance Officers Comment**

The project will require formal approval as an amendment to the Capital Programme; the case will therefore be determined by the capital charges for the project compared to the revenue savings that will be generated.

It is understood that the equipment has a life of 20 years

The capital charges for this project will consist of:

- the Minimum Revenue Provision, i.e. the charge to the revenue account for the use of capital which will be in accordance with the PCC policy of a straight line charge based on the life of the asset. In this case £17.5k per annum
- The Interest cost of using the capital in this case the charge is influenced by the availability of funding from the Government via Salix it is understood that these funds can be drawn down on a staged basis based on the Certificates of completion issued by the Installer. Interest charges in this case are based on 3.5% as an indicative value for current 20 year financing via the PWLB.
- Assuming that the work is completed within the first year and the first repayment commences in that year, the following table shows the likely cash flow over the life of the Project assets:

It can be seen that after the effect of the short term cash flow is removed the project will demonstrate a capital cost of £29.7k per annum compared to revenue saving of £93.4k a long term saving of £63.7k per annum.

It is proposed that this approach to financing the scheme is taken in order to generate both short term and long term savings. Dealing with the financing in this way also means that should the Salix financing not be available the scheme should still progress as whilst early savings would be lower an annual return would still be generated.
