A. NON-CONFIDENTIAL FACTS AND ADVICE TO THE PCC

A1. INTRODUCTION AND BACKGROUND

- The National Police Coordination Centre (NPoCC) was set up in April 2013. It previously reported to the Association of Chief Police Officers' (ACPO) President before ACPO was dissolved on 31 March 2015. It was agreed that NPoCC should continue as an independent national Unit, managed on a day to day basis by the Head of NPoCC, reporting from 1 April 2015 to the Chair of the National Police Chiefs' Council (NPCC).
- 2. NPoCC is a non-legal entity and is a collaboration between Chief Officers. The host force is the Metropolitan Police Service. Its functions are to support

the operational national co-ordination of operations, police response to national emergencies, mobilisation of resources across force borders and internationally, and police service response to UK disaster victim It also coordinates the police service response and provides representation during COBR, and assesses national capacity and capability in relation to the Strategic and National Police Requirements, maintaining information and data sets relating to policing specialist skills and assets for the benefit of the police service. It coordinates a continuous testing and exercise regime to ensure effective mobilisation of national assets in a crisis.

- NPoCC is responsible for developing reporting mechanisms with the Home 3. Office and central government crisis management.
- The attached document, the National Police Collaboration Agreement in 4. relation to the National Police Coordination Centre ("NPoCC"), is the Section 22A Collaborative Document that sets out the arrangements that underpin this organisation.
- In order that both the Police and Crime Commissioner and the Chief 5. Constable of Lincolnshire Police can have confidence that appending their signatures is sensible, legal and appropriate, the document has been scrutinised and comments fed back through the East Midlands Police Legal Services, led by Craig Sutherland. EMPLS have played an important role (along with the legal teams in other forces collaborating in respect of NPoCC) in the shaping of this final document.

- The agreed share in relation to the proportion of any financial amounts to be 1. paid by the Funding Parties (FSS Share) is set out in Schedule 4 of the Agreement. In Lincolnshire's case this equates to 0.80% of the total and an indication has been given that this is £15,156.91 for the financial year 2016/17.
- 2. Insurance arrangements are to be made by the host force for direct employees, with forces maintaining their own insurance for officers under the direction and control of the Chief Constable.
- Any liabilities arising in relation to the running of NPoCC or the default, act, 3. omission or negligence of the Head of NPoCC shall be shared between the Funding Parties in proportion to that Funding Party's FSS Share.

4. Any liabilities arising in relation to an operational policing activity coordinated and supported by NPoCC but due to the default, act, omission or negligence of police officer shall be the responsibility of the Chief Constable with direction and control of that police officer.
