#### EXECUTIVE SUMMARY AND PURPOSE OF REPORT

The original Cross Border Agreement was signed regionally in May 2012. Since then, the collaborative working arrangements have continued to mature and are now very well embedded within EMSOU and the five constituent forces and South Yorkshire Police. The main substance of the original Agreement has served the region very well and therefore remains unchanged.

In 2021 the agreement was amended to include the addition of the Investigatory Powers Act 2016, this was subsequently signed off by the Six Chief Constables and the respective PCC/PFCC, including CC Chris Haward and the PCC Marc Jones.

This agreement strengthens the region's position with respect to activities undertaken by IPA 2016, Police Act 1997 and RIPA 2000, to grant authorities in relation to the acquisition, retention and disclosure of communications data, grant authorisations to interfere with property, authorise the carrying out of directed surveillance and to grant targeted authorisations for obtaining data in operations concerning crime that would otherwise be unlawful.

RECOMMENDATION

That the PCC signs the agreement.

# A1. INTRODUCTION AND BACKGROUND

- 1. This is a request to revisit an existing collaboration agreement in respect of the cross border authorisation of RIPA requests.
- 2. For the purposes of the IPA and RIPA, this is an agreement under sec 22(A) of the Police Act 1996 that will allow the following:
  - an Authorising Officer power to grant an authorisation to interfere with property on an application made by a member of any of the five regional EM forces and South Yorkshire Police.
  - to permit Authorising Individuals (AI) within the authorising force to grant authorisations for officers within any of the regional EM forces and South Yorkshire Police to obtain communications data.
  - to permit an AI to issue an authority under IPA requiring the disclosure of communications data to an appropriate person in any of the regional EM forces and South Yorkshire Police.
  - to permit an AO for the purposes of Directed Surveillance or to grant an authorisation upon application by a member of any of the regional EM forces and South Yorkshire Police.
  - to permit a Senior Authorising Officer for the purposes of intrusive surveillance to grant an authorisation upon application by a member of any of the regional EM forces and South Yorkshire Police.
- 3. The Section 22 Agreement is attached in Part 2 of this agreement.
