A1. INTRODUCTION AND BACKGROUND

1. This report sets out changes that are required to the Revenue Budget and Capital Programme 2023/24 and of its financing, and Earmarked Reserves.

A2. REVENUE BUDGET 2023/24 CHANGES

MoJ Funding

2. Grant funding of £91k was notified post budget setting, this additional income will be included within Victim Services Grant with an expenditure budget created within Victims Commissioning.

National Uplift Funding

3. Grant funding of £240k for 10 additional officers in 2023/24 was notified post budget setting, this additional income will be included within National Uplift Funding reducing Reserves Budget Balancing.

Recurrent Funding Requirements

4. £209k to be transferred from Recurrent Funding Requirements to Digital, Data and Technology in respect to ERP Consultant Fees.

A3. TRANSFER TO AND FROM RESERVES

Approval is requested for the release of the following funds from earmarked reserves.

Performance & Productivity Reserve

It is proposed that £40k is released from the Performance and Productivity reserve to Digital, Data & Technology for Cesium.

Approval is requested for the transfer of funds to earmarked reserves.

Development & Partnership Working Reserve

Decision notice 018/2023 approved the release of £150k from the Development & Partnership Working reserve for Domestic Abuse Commissioning. In the event, this was not required and it is proposed that the transfer be reversed.

A4. CAPITAL PROGRAMME 2023/2024

The following change is proposed to the 2023/24 capital programme.

Upgrade of Road Safety Cameras

Budget and funding of £305k is required to be added to the in-year approved programme to fund digital average speed camera systems. All funding will be claimed back from Lincolnshire County Council through the Safety Camera Scheme and will therefore not have a financial impact on Lincolnshire Police.

The Revenue Budget changes are needed to ensure the budget will support the PCC's Strategies.

The Capital Programme assists in delivering the Asset Management Strategy, the Digital, Data and Technology Strategy and the Business Transformation Programme.
